*For Homeschooled Students Only:* Qualifications may be met by achieving a rank, within the immediately preceding year, in the upper 20% on one of the following tests: PSAT (Preliminary Scholastic Aptitude Test); PLAN (Preliminary American College Test); SAT-I (Scholastic Aptitude Test-I); ACT (American College Test); TAP (Tests of American Achievement and Proficiency); or the California Achievement Test.

**TO CONTINUE RECEIVING THIS DISCOUNT**, please send a copy of the Youthful Driver's most recent grade transcript, report card or similar official document. Please return this letter along with the requested document at least 60 days prior to the renewal date. If a Youthful Driver no longer qualifies, you may reapply for this discount when qualifications are met.
